EMA Coordinator, Chris Showal-

ter, explained a recent change in the EMA Commission bylaws consisted of removing the finance options that are not being utilized by our commission, and only keeping those which are used. Previously, the bylaws included all finance options, but Showalter explained lowa Code states we need to specify the particular option of funding, not list all five options. Motioned by Heidenwirth, second by Eddy to approve the updated bylaws. All ayes. Mo-

tion carried. Kip Ladage, Bremer County EMA Coordinator, was present to discuss SF 615 regarding declaring Emergency Medical Services (EMS) as an essential county service. Ladage handed out a document outlining SF 615 and explained the 3 public hearing readings, creating a county advisory council, how it is funding, and the importance of public education. Ladage shared where Bremer County is in the process and they have determined if they tax the maximum of \$0.75 per one thousand of taxable valuation, they will have approximately 1 million to create a functioning system, but their advisory council has yet to determine how that will be accomplished. Ladage explained he is option to work together with Butler County and create a regional system. Ladage and Jim Shuttle, also present, explained six counties are already working together in some capacity, under a medical directory board to establish common protocols and would like to extend those efforts. They are hoping to combine efforts on purchases, billing, dispatching, etc. Heidenwirth feels Greene has an effective volunteer service and is concerned other towns may agree with their local service and not see the need to fund a county service. Ladage pointed out the average age of most of the volunteers during business hours and how they will be nonexistent in the near future. Discussions were held regarding the other ambulance services utilized in Butler County including: Franklin General, Sartori, Grundy Center and Charles City and how that would all work. Sara Trepp, IT Director, mentioned she can hear dispatchers struggling to get transport services to the right area and Tammy Fleshner, Public

Health, emphasized the need for communities to start working together to address these issues as most will already need to establish an affiliate agreement. Showalter explained this would not replace existing entities, but enhance services and offer additional assistance. Ladage shared a personal story to illustrate the need for additional transport services. Eddy stated that most of us can see the value in doing this and citizens will see the value too. Barnett suggested putting this on an upcoming agenda to discuss beginning this process, establish how to move forward in Butler County and also work together with Bremer County.

Minutes of the previous meeting were read. Motioned by Eddy, second by Heidenwirth to approve the minutes as read. All ayes. Motion carried.

During public comment, County Engineer, John Riherd, shared that Landon Cleary, passed his Profession Engineer test and received his PE license. Riherd explained the career progression of an engineer after their degree includes a fundamentals exam, four years of work experience in a chosen field and then the professional exam. Riherd mentioned Cleary will continue to take on increased responsibilities in their office.

Motioned by Heidenwirth, second by Eddy to go into closed session to discuss Planning & Zoning Administrator, Misty Day, position, duties and salary. Motioned by Barnett, second by Eddy to return to open session. All ayes. Motion carried. Barnett shared discussions included both of Misty Day's positions duties with Planning and Zoning and the Environmental Health Department. EMA Coordinator, Chris Showal-

ter, explained a recent change in the EMA Commission bylaws consisted of removing the finance options that are not being utilized by our commission, and only keeping those which are used. Previously. the bylaws included all finance options, but Showalter explained Iowa Code states we need to specify the particular option of funding, not list all five options. Motioned by Heidenwirth, second by Eddy to approve the updated bylaws. All ayes. Motion carried.

Kin Ladage Bremer County FMA Coordinator, was present to discuss SF 615 regarding declaring Emergency Medical Services (EMS) as an essential county service. Ladage handed out a document outlining SF 615 and explained the 3 public hearing readings, creating a county advisory council, how it is funding, and the importance of public education. Ladage shared where Bremer County is in the process and they have determined if they tax the maximum of \$0.75 per one thousand of taxable valuation, they will have approximately 1 million to create a functioning system, but their advisory council has yet to determine how that will be accomplished. Ladage explained he is option to work together with Butler County and create a regional system. Ladage and Jim Shuttle, also present, explained six counties are already working together in some capacity, under a medical directory board to establish common protocols and would like to extend those efforts. They are hoping to combine efforts on purchases, billing, dispatching, etc. Heidenwirth feels Greene has an effective volunteer service and is concerned other towns may agree with their local service and not see the need to fund a county service. Ladage pointed out the average age of most of the volunteers during business hours and how they will be nonexistent in the near future. Discussions were held regarding the other ambulance services utilized in Butler County including: Franklin General, Sartori, Grundy Center and Charles City and how that would all work. Sara Trepp, IT Director, mentioned she can hear dispatchers struggling to get transport services to the right

Health, emphasized the need for communities to start working together to address these issues as most will already need to establish an affiliate agreement. Showalter explained this would not replace existing entities, but enhance services and offer additional assistance. Ladage shared a personal story to illustrate the need for additional transport services. Eddy stated that most of us can see the value in doing this and citizens will see the value too. Barnett suggested putting this on an upcoming agenda to discuss beginning this process, establish how to move forward in Butler County and also work together with Bremer County.

County Auditor, Leslie Groen, shared the report from the Temporary Redistricting Commission Public Hearing on the proposed precinct plans. Elections Deputy, Matt Wilken, provided maps of the proposed precincts. Motioned by Eddy, second by Barnett to adopt the proposed reprecinting plan through Resolution 1015 – 2020 Census Precinct Boundary Changes.
