OFFICIAL PROCEEDINGS NORTH BUTLER CSD BOARD OF EDUCATION MINUTES

OCTOBER 12, 2020

The regular board meeting was called to order by President Laurie Shultz at 6 p.m., in the Greene School Media Center. Board members present were Laurie Shultz; board members via Zoom: Eric Bixby, John Endelman, Amanda Lund and Addison Johnson; others present were Superintendent Joel Foster (via Zoom), Business Manager/ Board Secretary Shellee Bartlett and four visitors.

Moved by Bixby, seconded by Johnson, to approve the agenda. Carried unanimously.

Moved by Bixby, seconded by Lund, to approve the minutes from Sept. 14, 2020 and Sept. 23, 2020 meetings. Carried unanimously.

Moved by Endelman, seconded by Lund, to approve September 2020 financial reports and October 2020 bill listing. Carried unanimously.

Moved by Endelman, seconded by Bixby, to update school calendar as follows: April 5, 2021 will become a professional development day; April 6, 2021 will be a regular student day; Wednesdays in the month of November and December will be two hour late start for professional development and regular classes the remainder of the day. Carried unanimously.

Moved by Johnson, seconded by Endelman, to allow fine arts including concerts, plays and veteran's day program with events to follow the school's guidelines on social distancing and limited number of people. Carried unanimously.

Moved by Endelman, seconded by Bixby, to allow building usage for North Butler youth programs (North Butler students only) with guidelines for parents to stay in designated areas. Carried unanimously.

Moved by Johnson, seconded by Bixby, to approve the following recommendations: Lindsay Landers, 279 Nurse Contract (206 days for 2020-21 school year) at \$53,483.78; Jeff Stirling, JH Boys Basketball at \$1,727; the following substitutes: Cody Krumwiede and Taylor Salge. Carried unanimously.

Moved by Bixby, seconded by Endelman, to adjourn at 6:32 p.m.
